

SCA&HC 23rd Skylands Juried Exhibition & Sale

The Sussex County Arts & Heritage Council invites you to enter the 23rd Annual Skylands Juried Exhibition and Sale held September 11-25, 2010 at the Council Gallery 133 Spring Street, in Historic Downtown Newton, NJ. This years distinguished juror is Jeffrey Wechsler, Senior Curator, Jane Voorhees Zimmerli Art Museum.

Juror

Jeffrey Wechsler

Jeffrey Wechsler is Senior Curator at the Jane Voorhees Zimmerli Art Museum, Rutgers the State University of New Jersey. After receiving a Bachelor of Arts and a Bachelor of Fine Arts from Brooklyn College, he received an MA in Art History from Rutgers Univ. in 1975. Specializing in lesser known aspects of twentieth –century American art he has organized many exhibitions of American art, including *Surrealism and Americans Art, 1931-1947*, *Realism and Realities: The Other Side of American Painting, 1940-1960*, *Abstract Expressionism: Other Dimensions*, *Asian Traditions/Modern Expressions: Asian American Artists and Abstraction* and *Transcultural New Jersey: Crosscurrents in the Mainstream*.

Awards. Cash awards up to \$3000, awarded at the judge's discretion plus invitational gallery exhibits. Best in Show \$1,000.

Requirements

- The exhibit is open to all fine arts media including photography. Must 18 years and older to participate.
- 2-D work not to exceeded 44"x 44" including frame and 25lbs in weight.
- 3-D work not to exceed 5' in height including base, cover more than 4 square feet of floor area and weigh more than 50lbs.
- All work should be display ready. 2-D work framed and wired; works on paper under plexi or glass; sculpture must have its own appropriate stand.
- Only original work completed in the past 3 years and not previously exhibited in Skylands.
- *All work must be for sale with 25% gallery commission on all sales.*

Slide Submissions.

- Clearly label 35mm slides with artist name, entry #, title, with name at top front of slide.
- *Information on slide must match entry form.*
- ***Include a SASE for returning slides.***

Digital Submissions (both CD or emailed files). **CD's will not be returned to artist.**

- Label CD with artist name, entry #, title, *as written on entry form.*
- Files should be sent as a maximum quality jpg, with 768 pixels as the longest dimension. Images will be viewed in sRGB color space.
- Save the jpg as: **title. jpg** (*spaces between words allowed, file title must match entry form*),

Example : portrait in white.jpg . Number untitled work. **Example : Untitled #1.jpg, Untitled # 2 .jpg**

NOTE: If you submit a larger file or one in RGB color space (or no color space) the software used to open and process your file will automatically correct it for you. The automatic changes MAY give a lower quality display than an image submitted in the specified size and color space.

Email

- Email submissions to **entries@scahc.org**, with the files sent as attachments. Include your name in the body of the email.
- The subject line must include Skylands.
- Confirmation of receipt will be sent.
- Artists emailing submissions must also mail entry form & payment via USPS.

Non Refundable Application Fee

- \$35 for up to 3 entries, \$5 for each additional entry up to 5 total.
- Application must be received by July 31, 2010.
- For all entries, slide, CD or emailed files, complete the application form, include payment and SASE.
- Notification week of August 9th
